#### **SALES PROMOTION DECISION**

(hereinafter: the “Decision”)

2. After the system registers three products included in the campaign, the system will deduct the amount of the most favorable product and will be distributed proportionally to each of the products that are part of the promotion.
3. The sales promotion referred to clause 1. of this Decision will apply in the all retail premises of the Company.
4. The goods, to which 3for2 promotions applies, are clearly designated in the store, the discount is calculated at the checkout and refers to the cheapest product and is evenly distributed on the prices of all products.
